### IN THIS GAZETTE

- The Rawson Hall Trust (Abolition) Act 1989 comes into force today. This Act abolishes the Rawson Hall Trust, and vests its assets and liabilities in the Administration.
- The Tourist Accommodation (Ownership) Amendment Act 1989 comes into force today. This Act requires proposals by "non-resident owners" to acquire tourist accommodation to be referred to the Legislative Assembly.
- The Registration of Births, Deaths and Marriages Amendment Act 1989 comes into force today. This Act amends the Registration of Births, Deaths and Marriages Ordinance 1963 to make more flexible the rules governing changes of children's names.
- The Post and Telegraph Amendment Act 1989 comes into force today. This Act increases the annual fees for private postal boxes.
- The Absentee Landowners Levy Amendment Act 1989 comes into force today. This Act improves the Administration's ability to recover unpaid levy, and makes a number of other changes to the Absentee Landowners Levy Ordinance.

**PLEASE NOTE:** These summaries are prepared by the Legal Branch to explain very briefly the main purpose of a new law. Copies of laws can be purchased from the Legal Branch, Administration, Kingston. During passage of a law through the Legislative Assembly an explanatory memorandum or summary will often be laid on the table of the Assembly. These are publicly available and give useful information about proposed laws. A booklet is also available listing laws in force. The booklet is kept up-to-date with supplements.
