Natural Person -

Should be witnessed by an adult person who is not a party to the document.

Attorney -

Corporation -

If this document is executed by a corporation under seal, he form of execution should include a statement that the seal has been properly affixed. eg. In accordance with the articles of association of the corporation, each person attesting the affixing of the seal should state his/her position (eg Director/secretary) in the corporation.

Solicitor -

A solicitor may not execute this document on behalf of the mortgagee unless appointed under a registered power of attorney
