INSTRUCTIONS FOR COMPLETION

General

- ♦ The information collected by this form is authorised by the Land Titles Act 1996 and may be used for the purposes of that Act, and will be available for search pursuant to Section 30 of that Act. It will also be made available to Government agencies for statistical and administrative purposes and to non government persons and organisations concerned with land. A fee may apply to any or all of the above
- This document should clearly indicate the identifiers of all land affected
- Complete all boxes or rule out if inapplicable
- ♦ Execution of document by –

Natural Person - Should be witnessed by an adult person who is not a party to the document

Attorney - If this document is executed by an attorney to a registered power of attorney, it must set out

the full name of the attorney and the form of execution must indicate the source of his/her authority eg "AB by his/her attorney XY pursuant to Power of Attorney registered no........

of which he she has had no notice of revocation."

Corporation - If this document is executed by a corporation under seal the form of execution should

indicate a statement that the seal has been properly affixed. eg. In accordance with the articles of association of the corporation, each person attesting the affixing of the seal

should state his/her position (eg Director/secretary) in the corporation.

- ♦ Solicitor A Solicitor may not execute this document of behalf of an applicant unless appointed under a registered power of attorney
- Alterations should not be made by erasure but by scoring through with a pen and the words substituted written above them verified by initials in the margin.
- Typewriting and handwriting should be clear, legible and in permanent black ink.

- 2. Fill in the nature of the instrument by which the applicant/owner acquired title to the land, e.g. "conveyance to AB (applicant) from CD dated etc
- 3. State by whom the land is occupied and the nature of the occupancy, e.g. "as weekly tenant of the applicant/owner(s)" State if the land is unoccupied. If the land is the site of a building occupied by a number of tenants, it is not necessary to name them but state e.g. "Various weekly tenants of the applicant/owner(s)."
- 4. This declaration is to be signed
 - a) by the applicant/owner, if only one
 - b) by each applicant/owner, if more than one
 - c) by an agent holding power of attorney authorising the sale of a freehold estate in the land in the name of the applicant/owner, unless the power expressly prohibits his making an applicant; or
 - d) where the applicant/owner is a corporation, by its duly authorised officer, e.g. "X.Y. Co Ltd, by its Secretary, who certifies that he is duly authorised to make this application on its behalf.".
 - e) by the Registrar pursuant to any enabling provision of the Land Titles Act 1996
- 5. Document 1 in schedule 1 must always refer to the original Grant of Freehold (details of) please request details from the Registrar's Office if necessary.
- 6. Do not produce documents or abstracts of title earlier than Document 2 in Schedule 1
