## ELECTRICITY (LICENSING AND REGISRATION) ACT 1985 (NI) APPLICATIONS FOR ELECTRICAL CONTRACTOR'S LICENCE

To operate in the capacity on Norfolk Island, electricians are required to apply for an Electrical Contractor's Licence.

Application forms can be found on Councils website <u>Electricity Forms | Norfolk Island Regional Council</u>, and are to be lodged with Customer Care, Bicentennial Complex, Burnt Pine, Norfolk Island. Application forms will require approval by the Registrar of Electrical Contractors and electrical Mechanic. The following application fees apply:

•	for issue of electrical contractor's licence	\$48
•	renewal of electrical contractor's licence	\$31
•	duplicate electrical contractor's licence	\$19
•	issue of certificate of registration as electrical mechanic	\$31
•	duplicate certificate of registration as an electrical mechanic	\$19

Eligible Electricians are:

- a. Being a registered electrical mechanic under the *Electricity (Licensing and Registration) Act 1985* or eligible to be so registered
- b. Having not less than 2 year's practical experience as an electrical mechanic after acquiring the prescribed qualifications
- c. Being not less than 21 years of age and a person of good fame and character; and
- d. Being capable of supervising persons engaged in carrying out electrical wiring work OR Being the Manager/Agent of a business or company

The application to be accompanied by details of Electrician's qualifications.
